

## Package leaflet – information for the consumer

### Dietary supplement

### Film coated tablets

**Composition per 1 tablet:** *Yashad Bhasma* powders – 37.50 mg, *Shilajit Shuddha* – 37.50 mg, *Momordica charantia* fruits – 12.00 mg, extracts: *Cassia auriculata* seeds – 45.00 mg, *Emblica officinalis* fruits – 37.45 mg, *Curcuma longa* rhizomes – 30.00 mg, *Eugenia jambolana* seeds – 15.00 mg, *Enicostemma littorale* whole plant – 11.00 mg, *Gymnema sylvestre* leaves – 11.00 mg, *Melia azadirachta* leaves – 11.00 mg, *Pterocarpus marsupium* core – 8.00 mg, *Tinospora cordifolia* stems – 8.00 mg, *Swertia chirata* whole plant – 1.25 mg.

**Excipients:** potassium sorbate (E 202), sorbic acid (E 200), sodium benzoate (E 211), calcium phosphate, corn starch, calcium stearate, colloidal silicon dioxide, sodium starch glycolate, cross-carmellose sodium, crospovidone.

**GMO free.**

**Recommendations for use:** a dietary supplement is a source of biologically active substances of plant origin, improves carbohydrate metabolism.

**Diet supplements should not be used as a substitute for a varied diet.**

**Method of administration:** for adults, 2 tablets twice a day (morning and evening), 30 minutes before meals or as directed by a doctor. Duration of administration: 3–6 months or as directed by a doctor. Do not exceed the stated recommended dose for daily use.

It is necessary to consult a doctor before administration.

**Contraindications:** individual intolerance to the components of the product, children.

### Precautionary measures.

*It is very important to follow your doctor's instructions regarding a balanced diet and exercise.*

**Storage conditions:** at a temperature not exceeding 30 °C in a dry, dark place and out of reach of children.

### Package:

20 tablets in a blister, 1 blister in a carton box with a package leaflet, 5 packages in a carton box; 20 tablets in a blister, 5 blisters in a carton box with a leaflet.

Tablet weight: 655 mg.
